# **Sheriff on Campus**

Sherriff on campus has been working out very well. The rotation of three individual officers from the sheriff's department begins at 8:00am at the start of carline. The officer is then available all day with an office in the administration area where they are stationed. Periodic inspections of the outside doors and halls are performed and outside traffic control is done in the morning an afternoon carlines.

## **Random Search**

A letter to parents, with a list of questions and answers was sent out last month. The letter and question sheet were reviewed by legal prior to mailing.

A random selection of students has been generated by the Student Selection Randomizer (SSR). Test batch was run on Oct 11<sup>th</sup>.

Teachers and parents were notified regarding the procedure on October 17th

Legal Advisory: Currently the American Civil Liberties Union (ACLU) is reviewing several schools with similar policies. No legal tests have run in Georgia. "Question- Does the current state of violence in public schools raise the level of concern to a search without cause status? Litigation may soon follow. Metal detectors have stood and passed this question. Random searches have not.
